

OFFICIAL RULES FOR THE “TREASURE CAVE” CHEESE DIP A DAY INSTANT WIN GAME”

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

BY PARTICIPATING IN THIS INSTANT WIN GAME YOU DECLARE THAT YOU HAVE READ THE OFFICIAL RULES BELOW AND THAT YOU FULLY AGREE TO ALL OF THESE TERMS AND CONDITIONS.

DATES OF PROMOTION: The Saputo Cheese USA Inc. **Treasure Cave**® Cheese Dip a Day Instant Win Game (the “Instant Win Game”) starts at 12:00:01 PM Eastern Time (“ET”) on **June 4, 2018**, and ends at 11:59:59 PM ET on **August 31, 2018** (the “Entry Period”).
